

## Wisconsin 4-H Hall of Fame Nomination

In recognition of the Centennial of 4-H in Wisconsin, seriously consider implementing a Wisconsin 4-H Hall of Fame in 2014. A 4-H Hall of Fame would provide statewide recognition for individuals and external organizations with significant contributions to the Wisconsin 4-H Youth Development program on any level, preserve Wisconsin 4-H history and development, and has the potential to increase awareness of the 4-H Youth Development program. Potential recipients include 4-H volunteers, 4-H pioneers, external collaborating organizations and businesses, community leaders and retired Cooperative Extension staff.

### Implementation Framework

<b>Selection Process</b>	Selection process for the one per county individual or collaborating organization, or business determined at the county level, based on the established Wisconsin 4-H Hall of Fame criteria (signature of county UW-Extension educator required on the nomination signature page); selection of the balance of the initial 100 honorees made by state level committee based on submitted nominations (signature of UW-Extension educator required on the nomination signature page)	Selections made by state level committee based on submitted nominations (signature of UW-Extension educator required on the nomination signature page)
<b>Post Selection</b>	Nominator must electronically submit photo and 250 word bio describing the honoree's qualifications.	Nominator must electronically submit photo and 250 word bio describing the honoree's qualifications.

## Guidelines

- The Wisconsin 4-H Hall of Fame will utilize criteria consistent with the National 4-H Hall of Fame.
- Any group or individual is eligible to submit a nomination to the state selection committee.
- County 2014 priority nominations must include the signature of a county UW-Extension educator. All other nominations must include the signature of a county or state UW-Extension educator.
- Complete nominations include the nomination cover page, nomination signature page, and one-page Microsoft Word document outlining nominee's qualifications based on the 4-H Hall of Fame criteria.
- UW-Extension staff members must be retired for three or more years before being eligible for nomination.
- Unsuccessful candidates can be re-nominated for future consideration.

## Honoree Qualifications

4-H volunteers, 4-H pioneers, external collaborating organizations and businesses, community leaders, and retired UW-Extension staff who made significant contributions of time, energy, and/or resources to the Wisconsin 4-H Youth Development program on any level exemplifying the following criteria:

1. Citizenship as exemplified by participation in civic, community, state, regional and national public service activities evidencing concern for the welfare of others, especially as related to 4-H.
2. Leadership as exemplified by qualities of leadership and acceptance of leadership responsibilities in civic, community, professional and business related activities that directly or indirectly benefit 4-H.
3. Career Accomplishments as exemplified by accomplishments and success in his/her chosen career and as a mentor or role model.
4. Character as exemplified by evidence of the influence of 4-H involvement (if a 4-H alumni or volunteer) in the nominee's life and/or his or her commitment to 4-H.
5. Other Information for the selection committee.

## **Nomination Criteria – Expanded Version (Nominator Guide)**

The Wisconsin 4-H Hall of Fame recognizes **significant** contributions (depth, scope and impact) on any level. Selection is based on five criteria. Below are suggested questions to adapt for nominees (i.e. deceased 4-H pioneer, 4-H volunteer, 4-H donor, external collaborating organization or business, community leader, or Extension professional).

- (1) Citizenship as exemplified by participation in civic, community, state, regional and national public service activities evidencing concern for the welfare of others, especially as related to 4-H.
  - What resources/abilities, beyond leadership, has the individual or organization/business brought to their citizenship efforts?
  - How does the public service demonstrate concern for the welfare of others? For 4-H?
  - How do others describe the candidate's civic contributions?
  - How has this individual or organization/business made a difference through community, state, regional and/or national public service?
  
- (2) Leadership as exemplified by qualities of leadership and acceptance of leadership responsibilities in civic, community, professional and business related activities that directly or indirectly benefit 4-H.
  - What leadership qualities does the individual or organization/business demonstrate across all leadership experiences: professional, community, personal?
  - How does this candidate empower groups he/she leads?
  - What difference has the leadership of this individual or organization/business made in the lives of others, especially 4-H and other youth?
  - What concepts or beliefs are evident in this candidate's way of leading?
  - What "personality" have they brought to the workplace or community service experience?
  - How has the candidate's leadership contributions directly or indirectly benefited 4-H?
  - What has been the influence of 4-H on the ability of the individual to assume leadership positions.
  
- (3) Career Accomplishments as exemplified by individual or organization/business accomplishments and success in chosen career field and as a mentor or role model. This includes tangible things done, such as programs implemented, resources raised, writing, business success, number of people affected, measured impacts on the lives of others, etc.
  - What evidence is there of an application of mission and vision during the candidate's career or manner of conducting the organization or business?
  - How have the candidate's career accomplishments and successes impacted others?
  - What examples of being a role model or mentor stand out?
  - How are things different because of this candidate's career or organization/business contributions?
  - What new innovations or approaches has this candidate introduced and sustained? And, how do others describe the candidate's accomplishments?
  - Describe the magnitude of the candidate's career accomplishments and success.
  - What has been the influence of 4-H on the career accomplishments of the individual or on that of the collaborating organization/business?
  
- (4) Character as exemplified by evidence of the influence of 4-H involvement (if a 4-H alumni or volunteer) in the nominee's life and/or his or her commitment to 4-H. The impact of 4-H involvement in the candidate's life is critical to the nomination. For those who may not be 4-H alumni, describe, if possible, where their commitment to 4-H originates and is strongly demonstrated.
  
- (5) Other Information for the Selection Committee. Consider adding things such as:
  - Significant recognition
  - The primary reason the candidate is being nominated

## 2014 Wisconsin 4-H Hall of Fame Nomination Cover Page

The Wisconsin 4-H Hall of Fame is being established in 2014 to recognize individuals and organizations with significant contributions to the Wisconsin 4-H Youth Development program on any level. Potential recipients include 4-H volunteers, 4-H pioneers, external collaborating organizations and businesses, community leaders, and retired Cooperative Extension staff. In 2014, every county is eligible to select one individual or external collaborating organization or business for this statewide recognition. Additional open nominations can be submitted by any group or individual for consideration by the state level selection committee. - 2. Leadership** as exemplified by qualities of leadership and acceptance of leadership responsibilities in civic, community, professional and business related activities that directly or indirectly benefit 4-H.
- 3. Career Accomplishments** as exemplified by accomplishments and success in his/her chosen career and as a mentor or role model.
- 4. Character** as exemplified by evidence of the influence of 4-H involvement (if a 4-H alumni or volunteer) in the nominee's life and/or his or her commitment to 4-H.
- 5. Any other information** that would be beneficial for the selection committee to know.
