If you've already sent feedback, thank you. Your input will help UW-Extension design programs that are more relevant, flexible, and digital; more fiscally sustainable; and better able to serve communities and organizations statewide.

I know this is a difficult time. Our budget cut target of \$3.6 million is significant, and we need to confront fiscal realities while continuing to fulfill our essential roles across the state.

There is a good deal of uncertainty at this point, but please know that I care deeply about Cooperative Extension and its future. I sincerely thank you for your interest and engagement in this process.
